WHEREAS, in terms of Section 14(1) of the NCTE Act, Periyar University Dept of Education, Plot No.24/1, Bangalore Main Road NH-7, Kottagoundampatty Village, Salem PU Post Office, Omalur Taluk, Salem City and District-636011, Tamilnadu has applied for grant of recognition to Periyar University, Plot No. 24/1, Karuppur Village, Salem PU Post Office, Omalur Taluk, Salem City and District-636011, Tamilnadu for B.EdPart-Time course online on 10.06.2015 for three years duration under section 14(1) of the NCTE Act, 1993 and hardcopy received by Southern Regional Committee of NCTE on 11.06.2015.
