## **M.Phil Regulations (Full Time)**

### **Eligibility for admission**

Candidates who have qualified for M.Sc Costume Design and Fashion, Textiles and Apparel Design, Textiles and Fashion Design, Fashion Technology, Textiles and Clothing or any M.Sc Degree related to Textiles and Fashion discipline are eligible to register for the degree of Master of Philosophy (M.Phil) in Textiles and Apparel Design.

For Full - Time M.Phil registration, candidates shall be required to have obtained a minimum of 55% marks at post graduate level. In case of candidates belonging to SC/ST community, the minimum percentage of marks for registration is 50%.

### **Duration of the course**

The duration of the M.Phil Course shall extend over a period of one year from the date of commencement.

### **Structure of the course**

The course of study for M.Phil degree shall consist of

**Part-I** comprising three written papers

Paper-I Research Methodology in Textiles and Apparel Design

Paper-II Advanced paper in Textiles and Apparel Design.

Paper –III related to the proposed dissertation.

## **Part II- Dissertation**

The exact title of the Dissertation shall be intimated within one month after the completion of the written examination. The students will not be permitted to make any changes in the title after completing the paper III examination. Candidates shall submit the Dissertation to the University through the Supervisor and Head of the Department at the end of the year from the commencement of the course which shall be valued by internal examiner (supervisor) and one external examiner appointed by the University from a panel of four names sent by the Supervisor through the Head of the Department at the time of submitting the dissertation.

The examiners who value the Dissertation shall report on the merit of candidates as “Highly Commended” (75% and above) or “Commended” (50% and above and below 75 %) or “Not Commended” (below 50%).

If one examiner commends the Dissertation and the other examiner, does not commend, the Dissertation will be referred to a third examiner and the third valuation shall be final.

Submission or resubmission of the Dissertation will be allowed twice a year.

### **Viva voce**

The Viva-voce will be conducted with the following Members.

- (i) HOD –Member of the Viva Board
- (ii) Guide – Chairman of the Viva Board
- (iii) External examiner from other University area – Member of the Board of Valuation and

Member of viva board

### **Passing Minimum**

A candidate shall be declared to have passed Part-I of the examination if he/she secures not less than 50% of the marks in each paper including Paper –III for which examination is conducted internally.

A candidate shall be declared to have passed Part-II of the examination, if his/ her dissertation is atleast commended.

### **Restriction in number of chances**

No candidate shall be permitted to reappear for the written examination in any paper on more than two occasions or to resubmit a Dissertation more than once. Candidates shall have to qualify for the degree passing all the written papers and dissertation within a period of three years from the date of commencement of the course.

### **Conferment of Degree**

No candidate shall be eligible for conferment of the M.Phil degree unless he/she is declared to have passed both the parts of the examinations as per the Regulations.
