Internal Quality Assurance Cell (IQAC) meeting of Periyar University was held on 12.05.2023 at 3.00pm in the Syndicate Hall. The meeting was presided over by the Hon'ble Vice Chancellor Prof. R.Jagannathan, the Chairman - IQAC.

	AQAR Preparation and Submission
2.	Annual Quality Assurance Report (AQAR) has to be submitted to the NAAC every year. The NAAC has extended timeline for submission of Previous AQARs upto 31 st May 2023. Periyar University has been exempted from submitting the last year AQAR (2021-22) due to award of accreditation. To start the preparation of AQAR 2022-23, AQAR preparation committee (Criterion incharges and members) meeting was held on 26.04.2023. This committee suggested collecting the data from the departments, cell, centres and administrative offices using the existing data collection template (Excel file) and fixing 07.07.2023 as the last date. There will be minor changes in the template/ data to be collected for the AQAR 2022-23 based on the guidelines of NAAC. The matter is placed before the IQAC committee for Approval of data

	Also, It was resolved that the IQAC has to prepare and submit a summary report to the Hon'ble Vice Chancellor highlighting the focus areas that require more attention by taking inputs from the NAAC peer team report.

Academic and Administrative Audit (AAA)

The National Assessment and Accreditation Council (NAAC) expects the Institutions to undertake continuous Academic and Administrative Audits (AAA). Academic audit is a scientific and systematic method of reviewing the quality of academic process in the institution. It is related with the quality assurance and enhancing the quality of academic activities in HEIs. Administrative Audit is a process of evaluating the efficiency and effectiveness of the administrative procedure. It includes assessment of policies, strategies & functions of the various administrative departments, control of the overall administrative system. etc. NAAC has not prescribed any specific methodology or guidelines for conducting AAA. It is expected that each HEI may evolve its own guidelines and methodology by learning from good practices followed by leading institutions within and outside India. NAAC indicates that an internal exercise every year and involvement of external peers once in a three or five years could be a good option. In line with NAAC guidelines, A committee has been constituted by Hon'ble Vice Chancellor for the preparation and finalization of Proforma used for AAA data collection. Consequently, the IQAC is planning to conduct AAA using external peers (experts) by Second Week of July 2023.

Criterion - 6 and Criterion - 7 training programme for the affiliated colleges.

Tamil Nadu government expects Universities to train affiliated colleges in getting accreditation from NAAC. In this connection, IQAC has already conducted four training programmes covering the first 5 criteria out of the 7 criteria considered for the assessment by the NAAC. Considering the reopening of Colleges, IQAC is planning to conduct the Criterion - 6 and Criterion - 7 training programme for the affiliated colleges during the third week of July 2023.

NAAC (Margadarshan) Mentor-Mentee Scheme

NAAC has launched the new scheme (Named Margadarshan) to inspire all accreditation aspirant HEI's (Higher Educational Institutions) to come in to the fold of accreditation through mentoring. Under this Scheme, Periyar University signed separate MoU with its 6 affiliated (Mentee institutions) colleges on

20.01.2023. An expert committee formed for this purpose, approved by NAAC, has conducted one internal meeting on 15.02.223 and two external meetings (in the respective institutions) on various dates during the month of March. April and May 2023. NAAC has mentioned that the duration of the Mentor-Mentee Scheme is 3 months. The mentee institutions have made good progress, but have not submitted IIQA/SSR. Considering the progress made, IQAC wants to seek another 3 months extension from NAAC, and accordingly, continue to mentor these 6 mentee institutions. This matter is placed before the IQAC Committee for Approval. Minutes: **Approved** Organising FDP/ATP/PDP NAAC and Tamil Nadu government expects HEIs to train their employees (teaching and non-teaching) to acquire newer skills required to carry out their duties efficiently. NAAC expects at least 50 per cent of the HEIs employees get trained within a cycle (5 years). In this connection, IQAC in association with University departments/centres/cells has organised 4 Faculty Development Programmes and 2 Administrative Training Programmes from January 2023 to March 2023. IQAC wants to continue organising such FDP/ATP/PDPs programmes in the Academic year 2023-24 to cover at least 10 percent of the total employees and the remaining in subsequent years. The IQAC also like to include teaching and non-teaching staff of affiliated colleges for such programmes. This matter is placed before the IQAC Committee for further suggestions and approval. Minutes: **Approved** NAAC DVV Partner - Expression of Interest Until now, all the relevant data submitted by HEIs for NAAC Accreditation has been verified and validated only by few institutions. In order to broad-base this process, NAAC has sought Expression of interest for empanelment as Data Validation and Verification Partners with NAAC. Periyar University has expressed its interest on 05.04.2023 to become a DVV partner with NAAC. This matter is placed before the IQAC Committee for information. Minutes: Noted **Additional Agenda**
