9	Agenda / Suggestions	IQAC sought approval to organise an awareness programme on "AI tools" during the first week of July 2025. This was approved by the IQAC committee.
	Action Taken / Outcome	The above awareness programme on the title "Al Tools" was conducted for the students of University Departments by the IQAC on 05.08.25.
10	Agenda / Suggestions	Periyar University has operated with seven criterion committees during the previous cycle of NAAC assessment and accreditation, with each committee representing one of the seven assessment criteria. However, NAAC has recently reformed its assessment framework, expanding from seven to ten measurement criteria. It was resolved to constitute ten criterion committees to replace the previous seven-committee structure.
