## **ELECTION TO THE SYNDICATE BY THE SENATE**

It is hereby notified that the following elections to the Syndicate by the members of the Senate will be held as per **Section 24 (b) – (Class – II Other Members) (4) – of the Periyar University Act 1997.**

**"One member, not falling under any of the above three categories, elected by the Senate from among its members".**

**Note :**

All Senate Members are eligible to vote\*.

**Except :**

- \* The Syndicate Members who are elected by the three categories (Principals, Assistant Professor of affiliated Colleges and Professors of University Departments) are not eligible to contest for this election.
- \* The Syndicate Members who are elected by the two categories (Principals and Assistant Professor of affiliated Colleges) are not eligible to vote in this election.

Nomination forms are available in the Registrar's Office. Nomination should be sent so as to be received by the Registrar, Periyar University, Salem- 11 **NOT LATER THAN 07.03.2026 upto 3.00 P.M.**

The scrutiny of nominations will take place on the same day at 4.00 P.M. in the Registrar's Office.

Nomination papers shall be enclosed in an envelope addressed to the Registrar **BY DESIGNATION** and superscribed.

**NOMINATION TO THE SYNDICATE BY THE SENATE** as indicated below and sent by Registered Post (Ack. Due), so as to be received by the Registrar within the date and hour fixed, or delivered to the Registrar either in person or by messenger.

Nomination papers that are not enclosed in an envelope superscribed and sent by Registered Post or not delivered in person or by messenger as required above shall be declared invalid. An elector shall be eligible to subscribe either as proposer or as seconder in nomination papers only as many times as there are vacancies but not more.


