MINUTES OF 100TH SYNDICATE MEETING

A point of order was raised by Dr. I. Carmel Mercy Priya: with reference to the eligibility conditions for admission to academic programmes. She claimed that it should only be proper that the self financing colleges be consulted prior to fixing norms for admission.

The Chairperson of the Syndicate responded by stating that the norms for admission are determined by the orders issued by the Govt. of Tamil Nadu. He further, clarified that any reasonable expectation will be considered suitably.

Item 1 To consider the recommendations of the Examination Committee held on 18.06.2018 for ratification.

The Syndicate Sub Committee - Examination Committee meeting was held on 18.06.2018 and scrutinized the recommendations of the passing boards of UG and PG programme offered in the affiliated colleges as well in the University Departments. The results were published on 18.06.2018 afternoon based on the recommendations of the Examinations Committee. (See Annexure I, P.No. 137-140)

The recommendation of the Examinations Committee is placed before the Syndicate for ratification.

Ratified. The Syndicate recommends that negligent and irresponsible evaluation of answer scripts should invite debarment of the examiner concerned consequent on the second examiner differing significantly from the original evaluation.

The Vice Chancellor of Periyar University has intervened on this issue and assured the authorities of Local Fund that these things will not be happened in future and has given letter in writing that these objection para on housing loan of employees may be dropped in anticipating the ratification of the Syndicate. Hence, the housing loans obtained by the employees without the prior approval of the authorities up to 2017-18 may be considered sympathetically by the Syndicate and may be ratified. The records pertaining to this matter is enclosed. (See Annexure V, P.No.171-176)

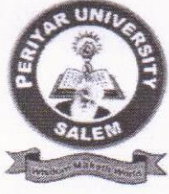
