# MEMORANDUM OF UNDERSTANDING [MoU] Between INFLIBNET Centre And Universities for Library Automation Programme

INFORMATION AND LIBRARY NETWORK CENTRE is an a inter-University Centre set up by the University Grants Commission to promote improved information access and transfer capabilities that support scholarship, learning, research and academic pursuits. The major activities of the centre are:

- Computerization and automation of libraries and information centre's to support modern information services.
- Up-skilling of existing library staff in the field of automation, computerization and networking of libraries-through regular training programmes, seminars and conventions.
- Creation and augmentation of databases to support academic and research work.
- Setting-up of a cooperative communication network for linking libraries and academicians to share print & electronic resources at national level.

This Memorandum of Understanding defines responsibilities, liabilities and commitments of the institutions involved to ensure proper system implementation to meet the objectives set out for the INFLIBNET Centre.

THIS AGREEMENT is made on the 15 day of FEB 2000 between INFORMATION AND LIBRARY NETWORK CENTRE (Hereinafter referred to as INFLIBNET) an Inter-University Centre of the UGC and PERYAR UNIVERSITY [University / Deemed University / Inter-University Centre] (Hereinafter referred to as the 'Member' of INFLIBNET).

WHEREAS PERYAR UNIVERSITY [University / Deemed University / Later University Centre] has agreed to became a full member of INFLIBNET for promotion and sharing of its library resources with INFLIBNET and other members/associate members of INFLIBNET.

Now it is hereby agreed as follows:

#### INELIBNET shall:

- 1. Recommend to the UGC to provide financial assistance to member institutions (12 B University) for procurement of a suitable computer system.
- 2. Recommend to the UGC to provide partial financial support to the member for retrospective data conversion o bibliographic records.
- 3. Provide system configuration, specifications and technical guidance to the member for procurement/augmentation of computer hardware and related systems.
- 4. Provide necessary software to the member for computerized operation of its library and for accessing other databases available in the Network.
- 5. Provide technical assistance and recommend to the UGC to include member institutions in the UGC-Infonet Connectivity Programme and the UGC-Infonet Digital Library Consortium Programme.
- 6. Provide training to a team of at least two persons (one from library field and one from computer field) from member's organization in computerized operation of library.
- 7. Provide help and guidance to the member to create and update various types of databases in member's library to support academic and research work.
- 8. Provide assistance in setting up computer laboratory and LAN in the library.

#### The Member shall:

- Commit to computerize its library and provide necessary infrastructure including manpower support far computerized operation of its library and its branch/ departmental libraries.
- 2. Ensure speedy installation/augmentation of computer system including software in its library with financial assistance and as per the guidelines laid down by the INFLIBNET/UGC.
- Commit to utilize the assistance provided by the INFLIBNET for fulfillment of the objectives of the INFLIBNET.
- 4. Depute at least two persons from its organization (one from library field and other from computer field) for undergoing training organized by INFLIBNET.
- 5. Ensure that the two person trained by INFLIBNET, are deployed on computerizing member's library.
- Arrange to provide training to users of its library and staff of colleges affiliated to member's organization in computerized library operation.
- Use the software provided by INFLIBNET for computerized operations and networking of its library.
- 8. Create databases of holdings in its library as per standards/formats set out by INFLIBNET from time to time.
- 9. Commit its library resources/databases to be shared by INFLIBNET and other members/associate members of INFLIBNET.
- 10. Contribute the records of its holdings to the INFLIBNET's Union Catalogue (IndCat). The copyright of records created by the member on its own machine will rest with the Member University, but the copyright of the INFLIBNET's Union Catalogue (IndCat) shall rest with INFLIBNET. The libraries initially contributing records to the Union Catalogue will be duly acknowledged.
- 11. Provide inter-library loan and document delivery services on actual cost basis to other users of the network subject to copyright rules and regulations.

#### The Member shall not:

1. Use INFLIBNET databases for any commercial purposes. The member shall not rent, sell or license the use of or deliver or release or otherwise part with the possession of the systems/software or the INFLIBNET databases or any part thereof to any other party (individual, institution, organization, etc.)

#### It is further agreed that:

1. INFLIBNET may accept a library as a full member/associate member even if It has created its database using standards other than those prescribed by the INFLIBNET on the condition that the new records to be created by it will conform to standards adopted by the INFLIBNET.

INFLIBNET will, however, try to explore and advise such a library as to how to convert its old records into the records as per standards adopted by the INFLIBNET.

- 3. If the Member does not create standard records, cooperate with other members or associate members of INFLIBNET in exchanging information the INFLIBNET shall terminate the membership with three month's notice to the member.

#### Termination:

This contract may be terminated by notice of three months in writing if INFLIBNET or the Member has been responsible for a breach of its obligations and terms of this agreement. In such a case, the Member shall stop the use INFLIBNET facilities and databases and return any software/hardware provided by or through INFLIBNET back to INFLIBNET within the 3 months notice period. All disputes between the parties shall be settled through negotiation.

# UGC (MINIMUM STANDARDS AND PROCEDURE FOR AWARDS OF M.PHIL/PH.D. DEGREE), REGULATION, 2009

## New Delhi-110002, the 1st June 2009

F. 1-1/2002 (PS) Exemp.—In exercise of the powers conferred by clause (e) & (g) of sub-section (1) of Section 26 of University Grants Commission Act, 1956 (3 of 1956), the University Grants Commission hereby makes the following Regulations, namely:—

Short Title, Application and Commencement:

 These regulations may be called University Grants Commission (Minimum Standards and Procedure for award of M.Phil./Ph.D. Degree), Regulations 2009.

- 2. They shall apply to every University established or incorporated by or under a Central Act, Provincial Act or a State Act, every Institution including a constituent or an affiliated College recognized by the Commission, in consultation with the University concerned under clause (1) of Section 2 of the University Grants Commission Act, 1956, and every Institution deemed to be a University under section 3 of the said Act.
- 3. They shall come into force with effect from the date of their publication in the Gazette of India.
- 4. All Universities, Institutions, Deemed to be Universities and Colleges/Institutions of National Importance shall be eligible for conducting M.Phil. and Ph.D. Programmes.
- Notwithstanding anything contained in these Regulations or any other Rule or regulation, for the time being in force, no University; Institution, Deemed to be University and College/Institution of National Importance shall conduct M.Phil and Ph.D Programmes through distance education mode.

# ELIGIBILITY CRITERIA FOR M. PHIL/PH.D. SUPERVISOR

 All Universities, Institutions, Deemed to be Universities and Colleges/Institutions of National Importance shall lay down the criteria for the faculty to be recognized as Research Supervisor both for M.Phil and Ph.D. Programmes.

7. All Universities, Institutions, Deemed to be Universities and Colleges/Institutions of National Importance shall lay down and decide on annual basis, a predetermined and manageable number of M.Phil and doctoral students depending on the number of the available eligible Faculty Supervisors. A Supervisor shall not have, at any given point of time, more than Eight Ph.D Scholars and Five M.Phil. Scholars.

8. The number of seats for M.Phil and Ph.D. shall be decided well in advance and notified in the University website or advertisement. All Universities, Institutions, Deemed to be Universities and Colleges/Institutions of National Importance shall widely advertise the number of available scats for M.Phil/Ph.D studies and conduct admission on regular basis.

# PROCEDURE FOR ADMISSION

- (i) All Universities, Institutions, Deemed to be Universities and Colleges/Institutions of National Importance shall admit M.Phil doctoral students through an Entrance Test conducted at the level of individual University, Institution, Deemed to be University, College/Institution of National Importance. The University may decide separate terms and conditions for those students who qualify UGC/CSIR (IRF) Examination/SLET/GATE/teacher fellowship holder or have passed M.Phil Programme for Ph.D. Entrance Test. Similar approach may be adopted in respect of Entrance Test for M.Phil Programme.
  - (ii) It shall be followed by an interview to be organized by the School/Department/Institution/University as the case may be.
  - (iii) At the time of inverview, doctoral candidates are expected to discuss their research interest/area.
  - (iv) Only the predetermined number of students may be admitted to M.Phil/Ph.D programme.

- 12. The University shall not use electronic version of theses digitized using funds given by the UGC for any commercial purposes. The University shall not rent, sell or license the use of or deliver or release or otherwise part with the possession of the systems / software or the INFLIBNET ETDs databases, Shodhganga or any part thereof to any other party (individual, institution, organization, etc.)
- 13. The University will also commit their own funds or grants for fulfillment of the project, if the project on implementation of ETDs demands more resources and funds to complete it.
- 14. The University will use the plagiarism software recommended by the INFLIBNET and made accessible to test the thesis submitted by the student for plagiarism before awarding the Degree. If the university is not subscribing to such software, it will use the software from the nearest Regional Centre, if any.

#### III. Termination

Both, the Parties, will have rights to terminate the MoU at any time in case of breach of obligations and terms and conditions of the MoU. This MoU signed hereunder may be terminated by either party at anytime upon ninety (90) days prior written notice. Upon termination of this Agreement, the INFLIBNET / University will stop hosting their theses immediately while keeping the theses already deposited by the University in its archives for its users. The University shall stop using the INFLIBNET's ETD facilities and databases and return any software / hardware or digitized content provided by or through the INFLIBNET, back to INFLIBNET within the 3 months notice period.

IN WITNESS WHEREOFF, the parties hereto executed this MoU on this date above mentioned.

- The University will not hold INFLIBNET Centre responsible for any errors and omissions contained in the original theses.
- 4. The University commits to digitize theses and dissertations and their bibliographic records submitted to the university and provide necessary infrastructure including manpower support for operation of ETDs.
- Commits to utilize the assistance provided by the UGC on recommendation of the INFLIBNET for implementation of ETDs including their digitization.
- Deputes at least one person from the university (from library field or from computer field) for undergoing training on implementation of ETD organized by the INFLIBNET and ensure that the person trained by INFLIBNET on ETD is / are deployed for the same job.
- Arranges to provide training to research scholars or users of its library and staff
  of colleges affiliated to University in creation of electronic version of theses and
  their deposition in the ETDs.
- Ensures use of standard software and metadata schema suggested / provided by the INFLIBNET for setting-up / development / operation of its ETDs.
- Creates bibliographic records of all theses and dissertations submitted to the university in standard bibliographic formats prescribed by the INFLIBNET Centre from time-to-time and contributes these records for inclusion in the INFLIBNET's Union Catalogue (IndCat).
- Commits to sharing of library ETD resources / databases with the INFLIBNET Centre as well as with other universities.
- 11. The University would agree to host their ETDs in the digital repositories 'Shodhganga or other servers' set-up at the INFLIBNET Centre, and grant nonexclusive licence to the Centre to make electronic version of theses in full-text

data so as to avoid its loss. The INFLIBNET will deploy tools and techniques of digital preservation to ensure continuing access to scholarly content in digital formats and to protect them from media failure, physical loss and obsolescence.

- Recommend to the UGC to extend financial assistance to the University for digitization of theses and dissertations not available in computerized machinereadable format and / or for procurement and installation of a suitable computer system / infrastructure for creation of ETDs.
- Provide configuration of system, specifications and technical guidance to the University for procurement of computer hardware and related systems for setting-up of ETDs.
- Provide guidelines, technical standards and specifications for digitization of Ph.D. theses submitted to the university in past and for theses not available in computerized machine-readable format.
- Impart training to at least one person from the university (from library field and / or from computer field) in creation, updation and computerized operation of digital repositories of ETDs especially on 'Shodhganga'.
- Extend access to an anti-plagiarism software or provide services to evaluate theses for possible plagiarism and submit a report to the concerned university.
- The INFLIBNET may refuse to host any material deemed by the INFLIBNET to be controversial in nature or is in violation of copyright act.
- 8. This right of refusal will not relieve the University / Ph.D. scholar of liability, both to INFLIBNET and to the public, for matter contained in the theses that may be libelous or actionable and to both INFLIBNET and copyright owners for copyright infringement by the Ph.D. Scholar.
- 9. The INFLIBNET Centre will not be responsible for i) errors, omissions, inaccuracies and quality of content or misinformation or for any damages caused to the user or any third party from the use of content provided in the theses; ii) safety and archiving of loaded content in cases of "force measure" including natural calamities; and iii) printed version of theses.
- 10.INFLIBNET Centre will recommend or provide access to plagiarism software which university may use to detect plagiarism before awarding the degree.
- 11. The INFLIBNET Centre replicates the content of theses and dissertations on different server and other auxiliary storage media. However, the INFLIBNET Centre does not take the responsibility for the archiving or backing-up of loaded content. The universities, therefore, should also keep a back-up of their theses and dissertations.

# Memorandum of Understanding (MoU) for Shodhganga

(A Repository of Theses and Dissertations submitted to the Universities in India)

This Memorandum of Understanding (MoU) is made and entered into on 28 (Day) Mach (Month) 201) (Year) between the INFLIBNET Centre, an IUC of University Grants Commission located at Ahmedabad, hereinafter referred to as "INFLIBNET" and PERIYAR (University / Deemed University / Inter-University Centre), here in after referred to as the 'University'.

WHEREAS, INFLIBNET Centre, an Inter-university Centre of the University Grants Commission, as its mandate, promotes open access to scholarly content generated in universities. The Centre has computers, network, software infrastructure and technical know-how required for hosting electronic versions of theses and dissertations in open access with interface to search, retrieve and access these content.

PERIYAR WHEREAS (University / Deemed University / Inter University Centre) has agreed to take part in the process of digitisation of old theses and dissertations (not available in computerized machine-readable format) and building-up of digital repository and to promote, share and host its ETD in 'Shodhganga: A reservoir of Indian theses submitted to the Universities in India' and other universities in open access. 'Shodhganga' is a name coined by INFLIBNET Centre for refering to the respository of Indian Electronic Theses and Dissertations. The word "Shodh" originates from Sanskrit and stands for research and discovery. The 'Ganga' is the holiest, longest and largest river in Indian subcontinent which has held heart of its people captive and drawn millions of people to its banks since the dawn of history. The Ganga is the symbol of India's age-long culture and civilization, ever changing, ever flowing, ever loved and revered by its people. "Shodhganga", a repository of theses and dissertations submitted to Indian universities, is expected to keep growing to a formidable size as more and more researchers from India submit their research works to this ever growing reservoir.

The course work shall be treated as pre M.Phil/Ph.D preparation and must include a course on research methodology which may include quantitative methods and Computer Applications. It may also involve reviewing of published research in the relevant field. The individual Universities, Institutions, Deemed to be Universities and Colleges/Institutions of National Importance, as the case may be, shall decide the minimum qualifying requirement for allowing a student to proceed further with the writing of the dissertation.

If found necessary, course work may be carried out by doctoral candidates in sister Departments/ Institutes either within or outside the University for which due credit will be given to them.

# **EVALUATION AND ASSESSMENT METHODS**

- 14. Upon satisfactory completion of course work and research methodology, which shall form part & parcel of M.Phil/Ph.D. Programme, the M.Phil/Ph.D. Scholar shall undertake research work and produce a draft thesis within a reasonable time, as stipulated by the Institution concerned.
- 15. Prior to submission of the thesis, the student shall make a pre-M.Phil/Ph.D presentation in the Department that may be open to all faculty members and research students, for getting feedback and comments, which may be suitably incorporated into the draft thesis under the advice of the supervisor.
- 16. Ph.D candidates shall publish one research paper in a referred Journal before the submission of the thesis/monograph for adjudication, and produce evidence for the same in the form of acceptance letter or the reprint.
- 17. The thesis produced by the M.Phil/Ph.D student in the Institutions/Departments and submitted to the University, Institution, Deemed to be University, College/Institution of National Importance, as the case may be, shall be evaluated by at least two experts, out of which at least one shall be from outside the State. It shall be upto the University, Institution, Deemed to be University, College/Institution of National Importance concerned to have one examiner from outside the Country.
- On receipt of satisfactory evaluation reports, M.Phil/Ph.D students shall undergo a viva voce examination which shall also be openly defended.

#### DEPOSITORY WITH UGC

- 19. Following the successful completion of the evaluation process and announcements of the award of M.Phil/Ph.D, the University shall submit a soft copy of the M.Phil/Ph.D thesis to the UGC within a period of thirty days, for hosting the same in INFLIBNET, accessible to all Institutions/Universities.
- 20. Alongwith the Degree, the Degree awarding University, Institution Deemed to be University, College/ Institution of National Importance, as the case may be, shall issue a Provisional Certificate certifying to the effect that the Degree has been awarded in accordance with the provisions to these Regulations of the UGC.

Please refer to the letter from the Chairman, UGC vide his D.O. letter no.F.1-1/2007(IUC) dated 12th August, 2010 regarding submission of electronic version of theses and dissertations to the digital repository set-up at the INFLIBNET Centre. As mentioned in the letter written by the Chairman, UGC, the INFLIBNET Centre has already set-up a Digital Repository called "Shodhganga" to facilitate submission and hosting of electronic version of Ph.D. theses submitted to universities in India as per UGC Notification (Minimum Standards & Procedure for Award of M.Phil. / Ph.D Degree, Regulation, 2009).

We appreciate that your university is keen to join this initiative and extend access to research output from your university to the scholarly community world-wide. The universities are required to take the following steps to join this initiative:

- 1. Sign an MoU with INFLIBNET Centre to facilitate research scholars from your university to submit their theses into "Shodhganga" thereby granting non-exclusive rights to this Centre for hosting electronic version of all the theses submitted to your university. Signing of MoU with the INFLIBNET would also entitle 12(B) universities for the benefit that UGC may provide either directly to the universities or through INFLIBNET Centre in terms of funds for digitization of backfiles of theses or access to software tools to deter plagiarism in theses and dissertations.
- 2. Assign an officer of the university who would be responsible for authenticating the uploaded theses on behalf of the University. The INFLIBNET Centre will create an account in his / her name as "University Administrator". This process is introduced to ensure completeness and correctness of electronic version of theses submitted to the repository.
- 3. Formulate Ph. D guidelines or modify existing Ph.D guidelines wherein electronic submission of theses in the digital repository set-up at the INFLIBNET Centre may be made mandatory. The university may also instruct their students to submit the electronic version of their theses on CDs or any other storage media for university's own records.

It is understood that implementing regulations on submission of electronic version of theses through the academic bodies / syndicates of universities might take time. As such, you may encourage your students to submit their theses into "Shodhganga" on voluntary basis.

It may kindly be noted that students may submit electronic version of their theses into "Shodhganga" at the time of submission of theses, however, it will get published (made visible) on "Shodhganga" only after release of notification by the University regarding award of Ph.D. degree.

Enclosed please find a copy of the MoU for your kind perusal. Please do visit Shodhganga Web site (http://shodhganga.inflibnet.ac.in/) for further details. I am happy to inform you that a few universities have already signed the MoU and have forwarded their theses to us for uploading them into "Shodhganga.
